Case Study

ROYAL ALBION

Royal Albion Hotel, Brighton
- A distinguished 250-room, Grade II Listed landmark with over 200 years of heritage, occupying a prominent seafront position.

Client: Private Hotel Group

Location: Brighton Seafront, BN1

Duration: 12+ months ongoing

Scope: Full fire damage refurbishment, structural works

Over the past 12 months, The Bloomsbury Group has led the complex restoration of the historic Royal Albion Hotel in Brighton, following the catastrophic fire that devastated much of the site in 2023. Appointed as Principal Contractor and Chartered CIOB Building Company, we were responsible for every aspect of construction management, remediation, coordination and compliance on one of the most challenging heritage projects currently active on the South Coast.

Scope of Work

Our remit covered all technical, structural and logistical components of the restoration, including:

- **CDM Site Setup & Principal Contractor Role**

Full CDM compliance including hoarding, site compound, welfare facilities, and secure access for emergency inspections, surveyors, and consultants.

- **Appointment & Oversight of the Professional Team**

We directly appointed and managed a full project team:

- Conservation-accredited architects
 - Structural engineers
 - Planning consultants
 - Fire safety and building control specialists
- Regular design team meetings and reporting cycles ensured alignment at every phase.*

ROYAL ALBION

Scope of Work continued...

- **Construction Management & Site Remediation**

- Full fire and smoke damage remediation
- Removal of contaminated materials
- Specialist mould remediation throughout basement and lower levels
- Strip-out of fire-affected structures and materials

- **Heritage Roofing & Bespoke Timber Joinery**

We're currently overseeing the installation of a heritage-accurate slate roof, including handmade ridge tiles and leadwork to match original detailing. *Over 100 new timber sash and casement windows are being manufactured and installed to reflect the hotel's Regency-era façade.*

- **Asbestos Identification and Removal**

Licensed specialists carried out full asbestos removal across multiple wings of the hotel under our coordination. All works conducted under controlled conditions with appropriate certification.

- **Demolition, Excavation & Civil Engineering**

Partial demolition and structural stabilisation were carefully executed in consultation with structural engineers. Sub-structure excavation and temporary works were installed to facilitate safe reconstruction of compromised areas.

- **Utility Coordination & Local Authority Liaison**

We maintained ongoing liaison with:

- UK Power Networks, Southern Water, BT Openreach
- Brighton & Hove City Council planning, building control, and conservation teams
- Local fire authorities for site safety compliance

- **Fire Risk Assessment – Construction Phase**

Comprehensive fire safety strategy developed and implemented for all construction stages, including temporary fire exits, fire watch rotas, and HSE-approved risk mitigation measures.
